5. In the event of non-payment when demanded, Gregg's may use any legal means at its disposal to collect the account without further notice. Costs associated with any collection action taken are the responsibility of the applicant.
6. Gregg's reserves the right to require a separate personal guarantee of any person legally related to the applicant before granting credit.
7. Gregg's is to be advised in writing immediately of any changes to ownership, legal structure, and/or legal name of the business.
8. In order to reinstate a C.O.D. account, payment must be made in full including service charges and a new credit application must be processed.
